The meeting was opened by Mayor Groover followed by the invocation given by Mr. Reynolds.

Chief Pettus gave the Police Report.

- **FEMA/GEMA Hurricane Debbie(DR4821) and Helene Update(DR4830)**
  - Project is still in progress for Reimbursement for the Storm Costs
    - Met with FEMA Team this morning. .
    - DR4821 has been submitted and is awaiting a final review by the review team. (\$6770)
    - DR4830 will be submitted for review by the end of the week.

- **Immigration Reform (HB1105) and 287G Program**
  - Mandates Actions that must be taken by officers when encountering Foreign Nationals regardless of the country of birth.
  - In the event that we are directed to place a detainer of a subject, we must serve them the detainer and transport them to the Thomas County Jail.
  - I wanted to give this information to the council as a whole as a point of information and knowledge so that everyone is aware of this requirement.
  - As more is learned and guidance is provided by the Prosecuting Attorney's Council and Attorney General's Office, I will provide more information.
