The meeting was opened by Mayor Groover followed by the invocation given by Mr. Shiver.

Mr. Shiver motioned to approve the December 8, 2025 minutes. Mr. Reynolds seconded the motion. All in favor- Reynolds, Shiver, Jackson and West.

Attorney Kyle Swann gave Oath of Office to Mayor Danny Groover, Lawanda Jackson and Lavone Shiver.
